The joint guarantor will be handled by the corporation entrusted by our hospital, Entrust Inc. There will be no charge for this service.





- Upon admission to this hospital for treatment, patients are required to use the Guide to SUMAHOSU NEXT Joint Guarantor Agent System whereby Entrust Inc. acts as the patient's joint guarantor. Accordingly, as a general rule, it is not necessary for patients to secure an individual to act as their joint guarantor.
